The Board noted the information in the Head of School report related to: Economy, Community, Organization and Quality Assurance.

Economy

July Accounting Report and annual forecast presented. Surplus mainly due to Special Needs and UDIR funding as well as lower personnel and other operational costs than budgeted. Per July the financial position appears solid with YTD surplus of approx. 3,5 mil, which is approx 2,7 mil above budget. Income is higher than expected mainly due to higher grants than budgeted, as well as both personnel and operating costs remaining below budgeted levels (various factors). July shows a monthly deficit of 1,81 mil, primarily due to corrections of overpaid UDIR grants from earlier in the year, higher than usual monthly expenses, and the absence of school fee income during the summer break. While the overall financial outlook for 2025 remains positive, as reflected in the current annual forecast, based on the July accounting report, this will be reviewed with the Business Manager in October, to ensure a well-grounded assessment, in order to maintain a sustainable economy - as well as looking into possible plans for the future.
